CONDITIONS OF OFFER OF BURSARY

Purpose of Bursary

- The Bursary is made to you, a student who will study a degree in disciplines relevant to energy regeneration at university.
- The Tees Valley Community Foundation (TVCF) is prepared to consider variations to your declared course of study, but such variations should not take effect until written approval is obtained. If prior written agreement is not obtained, this may result in the whole Bursary paid to that date being repayable and the balance unpaid being cancelled.
- Any balance of the Bursary not used for the agreed purpose must be returned to TVCF.

Liability

- Whilst TVCF has approved the purpose to which the Bursary may be applied, you are entirely responsible for entering into any necessary contracts or agreements, and for compliance with any relevant law.
- TVCF does not have, and must not be held out as having, any relationship of principal and agent, or employer and employee, with you and has no liability for any of your actions or omissions, notwithstanding the expenditure of Bursary monies in pursuit of your approved course of studies.
- You agree that TVCF has no legal liability or responsibility for any claim for loss, damage or expense, which may arise directly, or indirectly, from your university studies supported by the Bursary.

Publicity

- TVCF should be acknowledged in any publications or press releases produced by you in respect of the Bursary award. In addition, TVCF may make their own contacts with the media for publicity purposes.
- TVCF will want to include details of the Bursary in their publications and possibly take photographs.
- You may be invited to receptions or meetings designed to inform TVCF supporters about the Foundation's work and it is important that you are prepared to take part in these events.
- You may be asked to contribute articles and photographs for publications and displays.

Payment

- Bursary award cheques of £500 will be issued to Bursary award holders in October, January and April in each academic year during the 3 / 4 year degree course. **Cheques will be released on receipt of a satisfactory brief progress report from your university tutor.**
- In the event that you do not complete your designated studies, the unexpended balance of any cheque paid must be repaid to TVCF.

Evaluation

- The final part of all TVCF grant-making processes involves a written evaluation, and a monitoring report. This will be sent to you after the final payment has been made and will have a 'return by' date on it for receipt by TVCF.
- TVCF is interested in any comments that will give us a fuller picture of what has happened as a result of the Bursary. The Foundation also welcomes feedback on its application processes.
- You may also receive a visit as part of TVCF's long-term monitoring strategy.
